## Full Release of Liability and Waiver Form

In consideration of being allowed to enter the play area, use inflatable equipment, soft playground or to participate in any party and/or program at Coconut Charlie's Bump'n Bounce (Kenwood Enterprises, LLC/landlord Greenway, LLC) located at 7409 Six Forks Road, Raleigh, North Carolina 27615, the undersigned, on his or her behalf and on behalf of the minors identified below, acknowledges, appreciates, agrees and is fully aware of the risks and hazards in participating in any of the activities on the premises of Coconut Charlie's Bump'n Bounce Family Fun Center (Kenwood Enterprises, LLC/landlord Greenway LLC) and further agrees as follows:

I agree for myself and/or the minor(s) listed below that we shall comply with all stated and customary terms, posted safety signs, rules and verbal instructions as condition of play and participation in any party and/or program at Coconut Charlie's Bump'n Bounce (Kenwood Enterprises, LLC/landlord Greenway LLC) Family Fun Center and agree to pay for all damages to the facilities of Coconut Charlie's Bump'n Bounce Family Fun Center(Kenwood Enterprises, LLC/landlord Greenway LLC) caused by myself or the listed minors' negligent, reckless, or willful actions. In addition, if I observe any hazard during out participation, I will bring it to the attention of the nearest Coconut Charlie's Bump'n Bounce Family Fun Center (Kenwood Enterprises, LLC/landlord Greenway LLC) employee or official immediately. I recognize and understand that there are certain inherent risks associated with the use of the play areas, parties and programs and that risks of injury include, without limitations, bruises, scrapes, cuts and even more serious injuries such as paralysis or death. Moreover, for myself and minor(s) named below, I fully accept and agree to assume all of these risks (including risks arising from the negligence of other participants) and I assume full responsibility for personal injury to myself and the listed minor(s) and our respective heirs, assigns, administrators, personal representatives and next of kin, waive, release and discharge Coconut Charlie's Bump'n Bounce Family Fun Center (Kenwood Enterprises, LLC/landlord Greenway LLC), its affiliates, officers, members, agents, employees, other participants and sponsoring agencies for injury, loss or damage arising out of or related to our participation in any and all of Coconut Charlie's Bump'n Bounce Family Fun Center (Kenwood Enterprises, LLC/landlord Greenway LLC) programs, activities, parties and/or the use of the facilities of Coconut Charlie's Bump'n Bounce Family Fun Center (Kenwood Enterprises, LLC/landlord Greenway LLC). This waiver and release shall be binding and apply to all risks, known and unknown, even if resulting from negligent actions of other guests.

Each participant must have a waiver form signed, either by them or if you are under the ages of 18 years, then signed by a parent/legal guardian or designated representative by parent/guardian. If a waiver is not signed, the person will not be able to participate in Coconut Charlie's Bump'n Bounce Family Fun Center (Kenwood Enterprises, LLC/landlord Greenway LLC) programs, parties and or use of the play areas, inflatables and playground equipment. "Rules of Play" include and are not limited to (a) **socks must be worn (no shoes or bare feet) in play arena** (inflatables, playground, arcade). (b) **Adults must supervise their children at all times** unless a designated Special Event is taking place where adult supervision is not necessary.

I further represent that the participants are healthy and physically able to participate in any and all undertaken activities.
